

2019 Income and Resource Limits for Medicaid and Other Health Programs

Public benefit programs (such as Medicaid) use the Federal Poverty Level (FPL) guidelines to determine who qualifies for coverage. The table below includes the current income and resource limits someone needs to meet to qualify for Medicaid, CHIP, and Part D Extra Help this year. The income limits are based on the 2019 FPL guidelines that were published in February.

Medicaid for Children and Pregnant Women	Full Medicaid coverage is available to children from birth through age 18 and Pregnant Women (the woman counts as 2 people or more depending on how many babies she is expecting).
